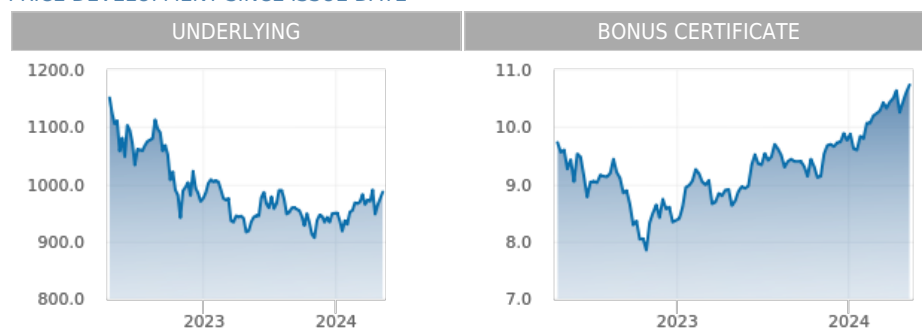
## DESCRIPTION
