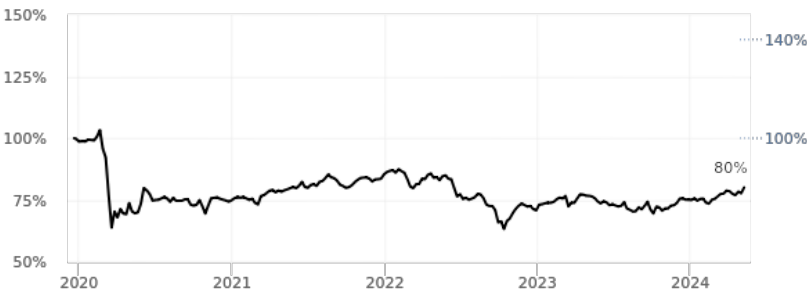

## The Underlying

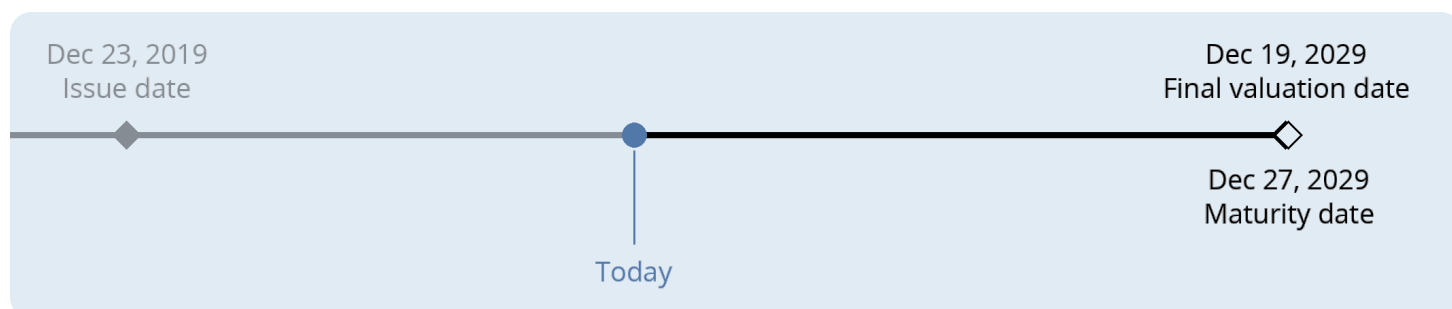
