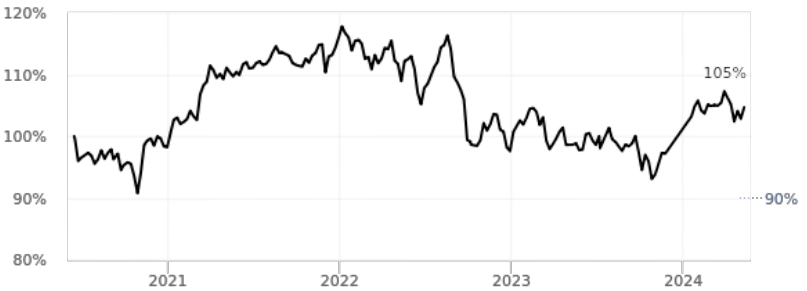

The Underlying

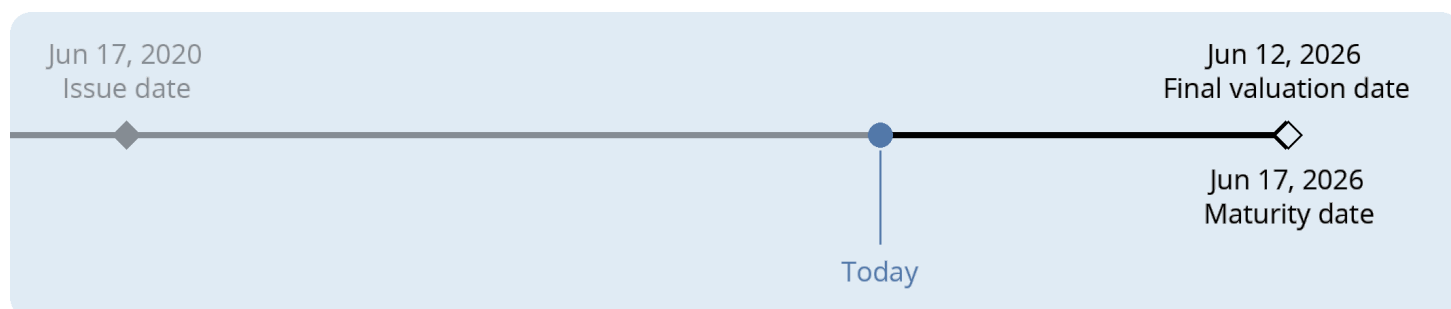
