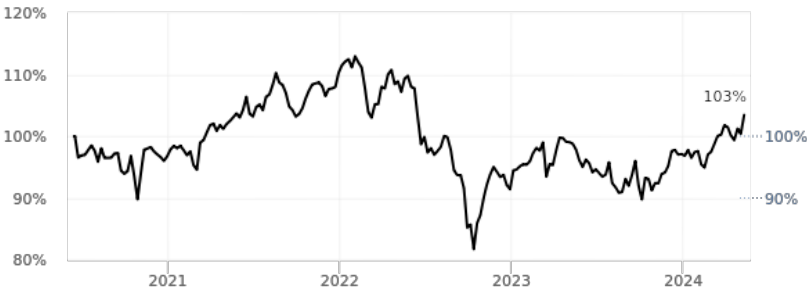

### The Underlying

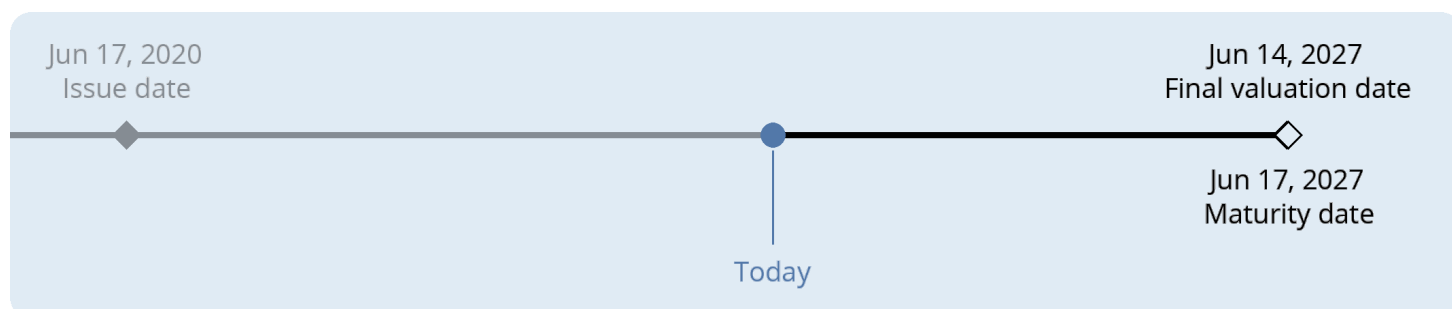
