

**Bekanntmachung gemäß Kapitel V 7.5 b des Basisprospekts vom 21. Juli 2008 der Raiffeisen
Centrobank AG**

*Announcement according to Chapter V 7.5. b of the Base Prospectus of 21 July, 2008
of Raiffeisen Centrobank AG*

Die Raiffeisen Centrobank AG, 1015 Wien, Tegetthoffstraße 1 gibt gemäß Kapitel V 7.5 b des Basisprospekts vom 21. Juli 2008 hinsichtlich der Open End Anlagezertifikate, ISIN: AT0000A08ZD9, Final Terms Nr. 245 v. 10.3.2008 wie folgt bekannt:

Aufgrund der Übernahme von AIG Financial Product Corp. ("AIG") durch UBS Securities LLC („UBS“) am 6. Mai 2009 wird der Dow Jones AIG Commodity® Index mit Wirkung per 7. Mai 2009 in Dow Jones-UBS Commodity® Index umbenannt. Der entsprechend abgeänderte Disclaimer lautet wie folgt:

Raiffeisen Centrobank AG, 1015 Wien, Tegetthoffstraße 1 announces in accordance with Chapter V 7.5.b of the Base Prospectus of 21 July 2008 in respect to the Open End Investment Certificates, ISIN: AT0000A08ZD9, Final Terms No. 245 of 10.3.2008 as follows:

UBS Securities LLC ("UBS") has acquired AIG Financial Product Corp.'s ("AIG") commodity business as of May 6, 2009. As such, the Dow Jones-AIG Commodity® Indexes will be re-branded as the Dow Jones-UBS Commodity® Indexes as of May 7, 2009. The amended disclaimer is as follows:

"Dow Jones®", "DJ", "UBS" "Dow Jones UBS CommoditySM," and DJ-UBSCISM" are service marks of Dow Jones & Company, Inc. ("Dow Jones") and UBS AG ("UBS AG"), as the case may be, and have been licensed for use for certain purposes **by Raiffeisen Centrobank AG.**
