In short:

With the Dividend Stocks Bond 90% IV investors obtain a yield of 32% if the underlying STOXX® Global Select Dividend 100 Price EUR index quotes at or above 100% of the starting value at the end of the term. In case of a negative index performance at the end of the term, redemption is effected at 90% of the nominal value (capital protection).

The past years were characterised by a low interest rate environment. The lack of investment opportunities forced many investors to seek for more profitable alternatives. One way out of the interest rate trap is represented by Capital Protection Certificates, which have already become an integral part of many investment portfolios due to their optimized risk/reward ratio.

Raiffeisen Centrobank AG is therefore issuing the **Dividend Stocks Bond 90% IV** especially for security-oriented investors who expect at least a moderate positive performance of the global dividend stock index **STOXX® Global Select Dividend 100 Price EUR** over the next 8 years. The certificate offers the opportunity to obtain a yield of 32% (3.5% p.a.) if the index quotes at or above 100% of its starting value at the end of the term. If the index quotes below its starting value after 8 years, redemption is effected at 90% of the nominal value (capital protection). FUNCTIONALITY

- At the initial valuation date the **closing price** of the STOXX® Global Select Dividend 100 Price EUR index is determined as **starting value**.
- At the final valuation date the closing price of the index is compared to the starting value and **one of the following scenarios will apply**:

SCENARIO 1: Index AT or ABOVE 100% of the starting value

Index ≥ 100% of the starting value → redemption at 132%

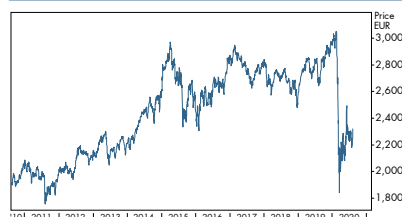
If the closing price of the index at the final valuation date is equal to or higher than the starting value, the redemption on the maturity date will be at 132% of the nominal value. This equals the maximum amount of EUR 1,320 per value. Investors do not participate in price increases of the index beyond +32%.

SCENARIO 2: Index BELOW the starting value

Index < 100% of the starting value → redemption at 90%

If the closing price of the index at the final valuation date is below the starting value, the capital protection will apply and the certificate will be repaid on the maturity date at 90% of the nominal value (equivalent to EUR 900 per nominal value).

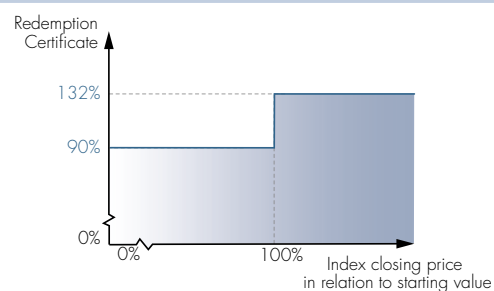
