#### DESCRIPTION

With the certificate **Europe/Austria Bonus&Safety 5** investors can obtain a bonus yield of 20% (based on the issue price) at the end of the term (November 2026) if the prices of the two indices EURO STOXX 50® and ATX 50® never decline by 51% or more of the respective starting value during the observation period. #### **FUNCTIONALITY**

At the initial valuation date, the **closing price of the EURO STOXX 50**® index and the **ATX**® index are fixed as **starting values** and the respective **barriers** (49% of the respective starting value) as well as the **bonus levels** (120 % of the respective starting value) are determined. The prices of both indices are continuously compared with the respective barrier during the observation period. At the final valuation date one of the following scenarios will apply:

### SCENARIO 1: Both indices always quoted ABOVE the respective barrier

If both the EURO STOXX 50° index **AND** the ATX° index always quoted above the barrier of 49% of their respective starting value during the observation period, the certificate is redeemed at 120% of the nominal value.
