FUNCTIONALITY

Beginning of the term:

At the initial valuation date the **closing price** of the STOXX® Global ESG Leaders Select 50 Price EUR index is determined as starting value and the cap (130% of the starting value) is fixed.

End of the term:

At the end of the term, the performance of the STOXX® Global ESG Leaders Select 50 Price EUR index is evaluated. The index starting value is compared to the index closing price at the final valuation date. Investors participate at 100% in the performance of the underlying index up to the cap of 130% of the starting value. Thus, the maximum payout is limited to EUR 1,300 per nominal value. In case of a negative performance of the STOXX® Global ESG Leaders Select 50 Price EUR index of more than 10%, the capital protection of 90% applies.

The **90% capital protection** by Raiffeisen Centrobank only applies at the end of maturity, i.e. during the term the certificate price may drop below 90%, but at the end of the term the investor obtains 90% of the nominal value in the worst case.
