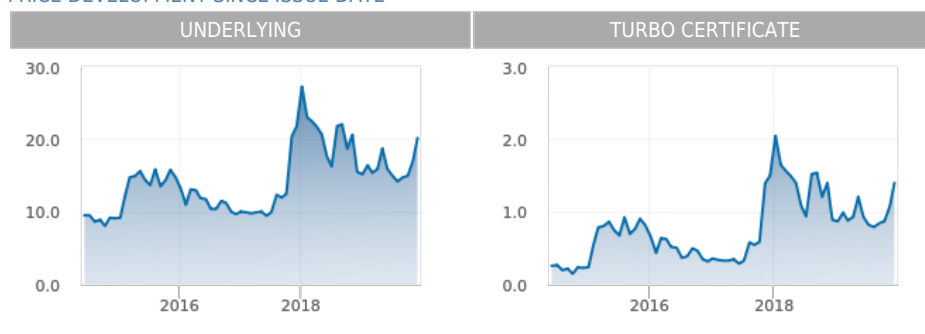
DESCRIPTION
