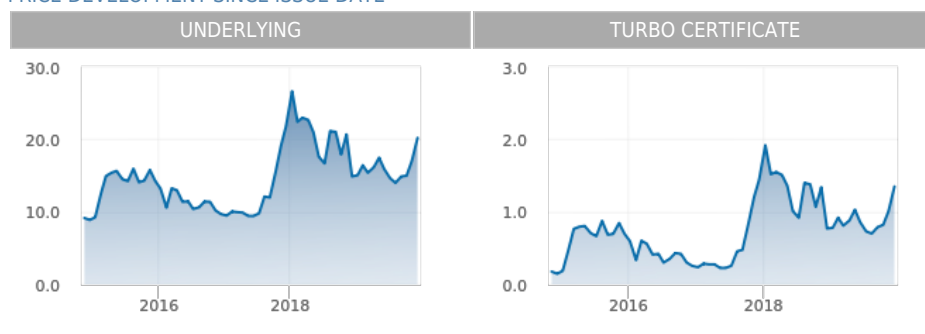
#### DESCRIPTION
