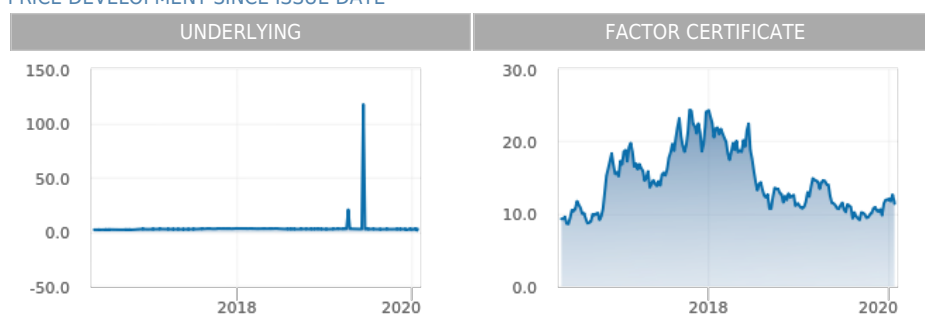
DESCRIPTION
