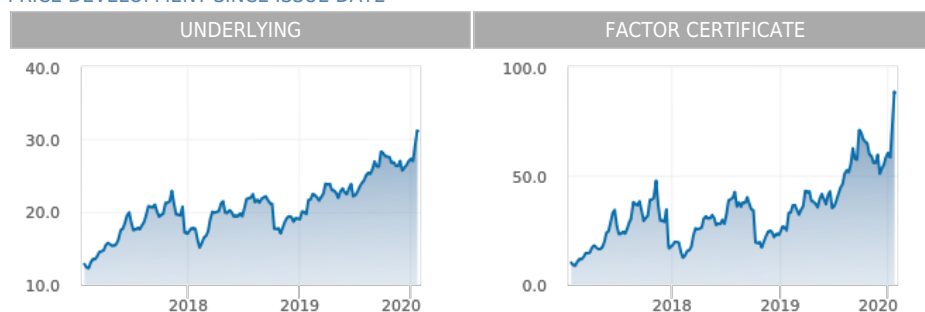
#### DESCRIPTION
