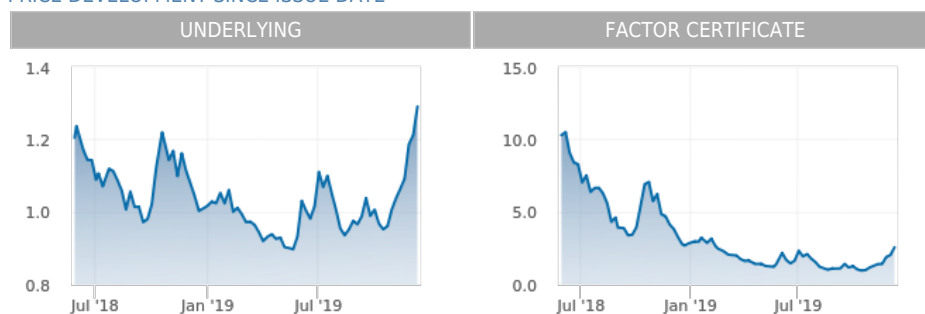
DESCRIPTION
