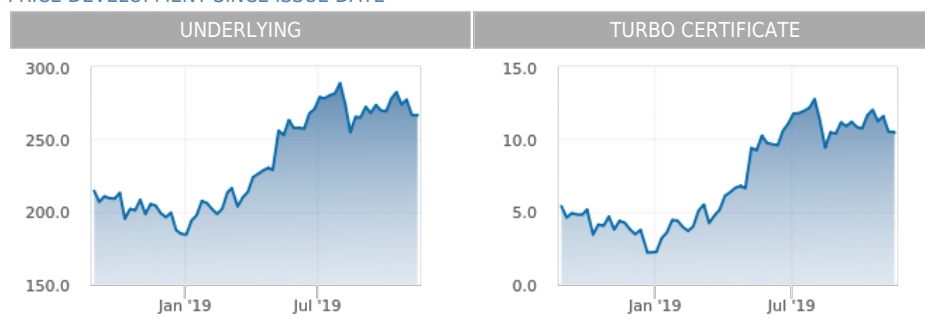
DESCRIPTION
