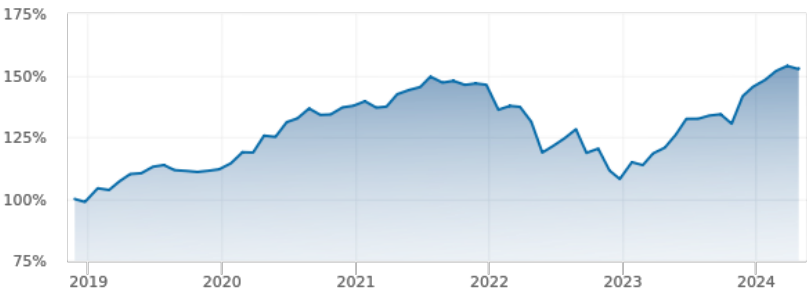

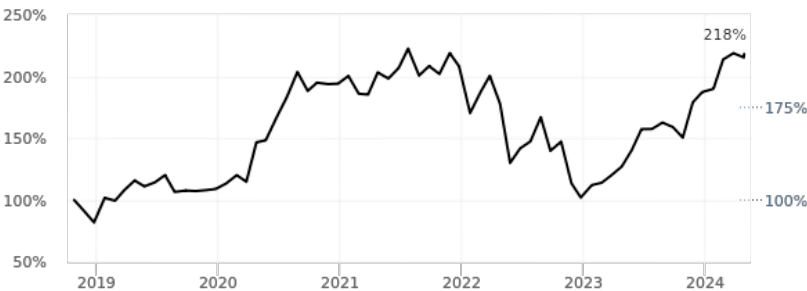

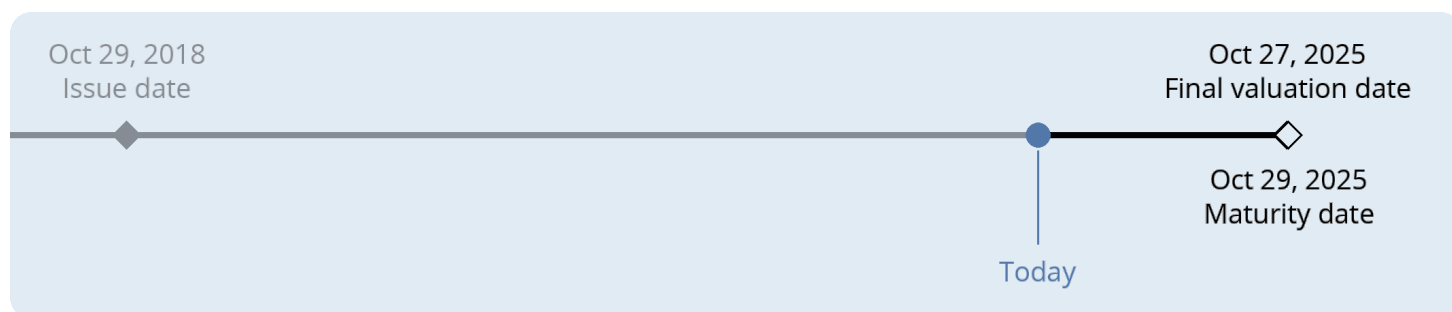
### The Certificate
