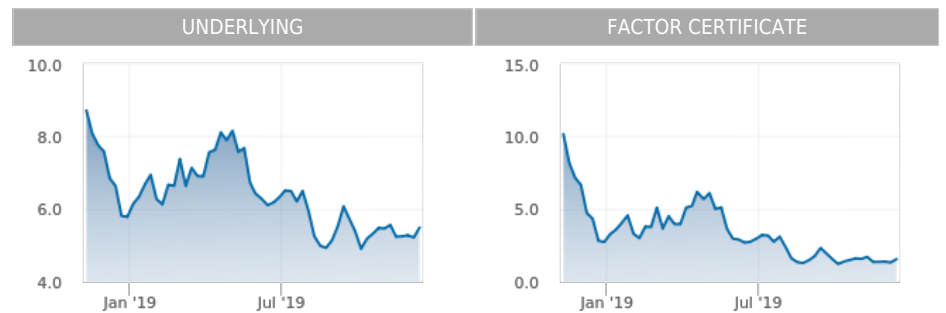
#### DESCRIPTION
