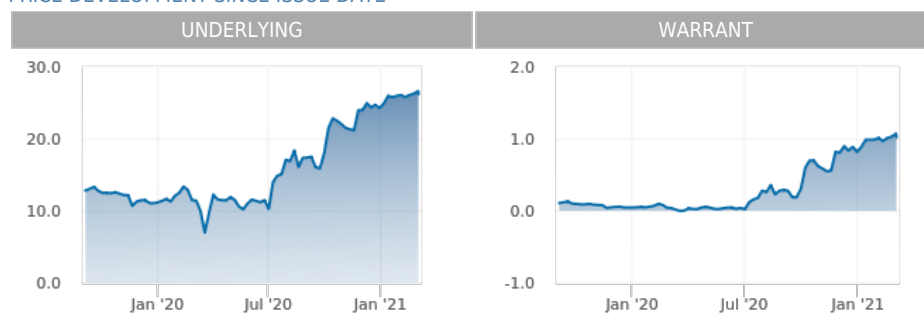
#### DESCRIPTION
