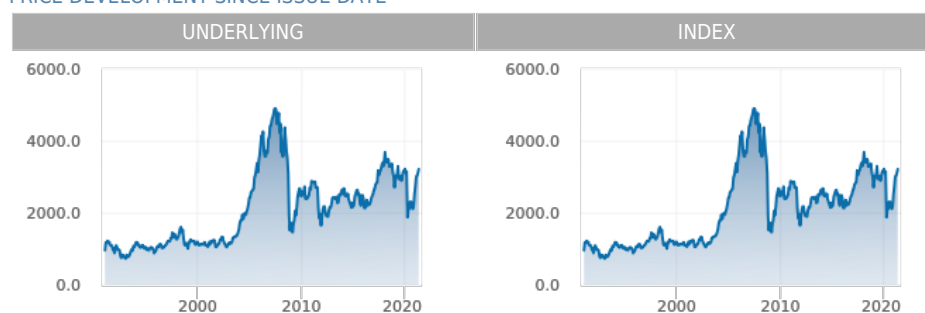

DESCRIPTION
