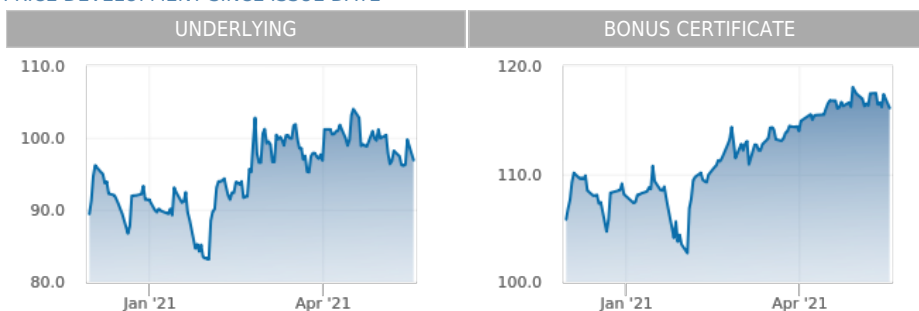

#### DESCRIPTION
