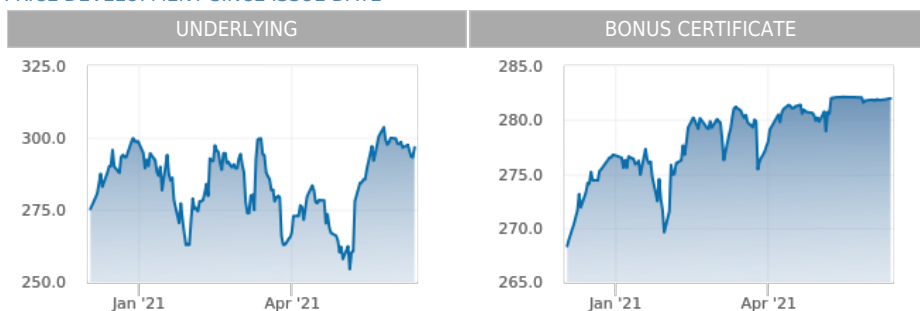

DESCRIPTION
