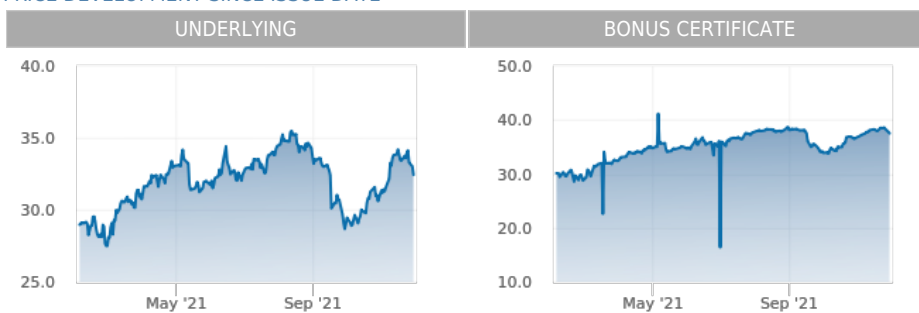

#### DESCRIPTION
