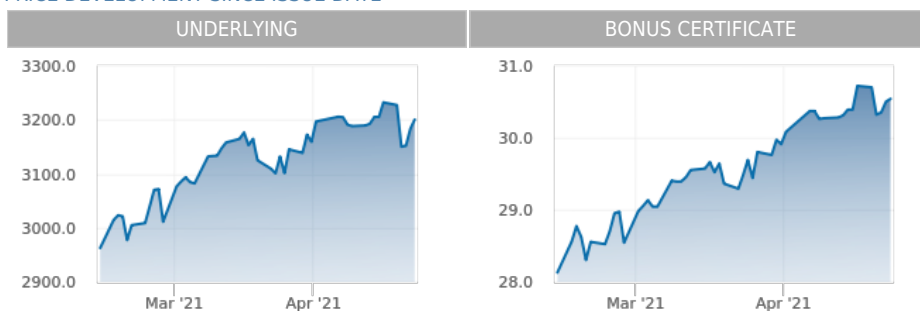

#### DESCRIPTION
