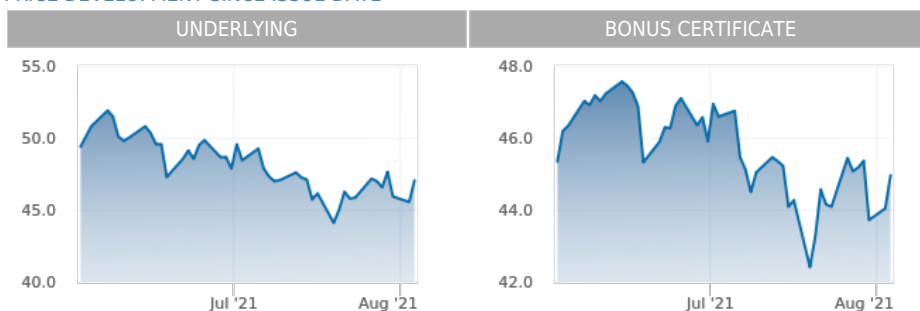

DESCRIPTION
