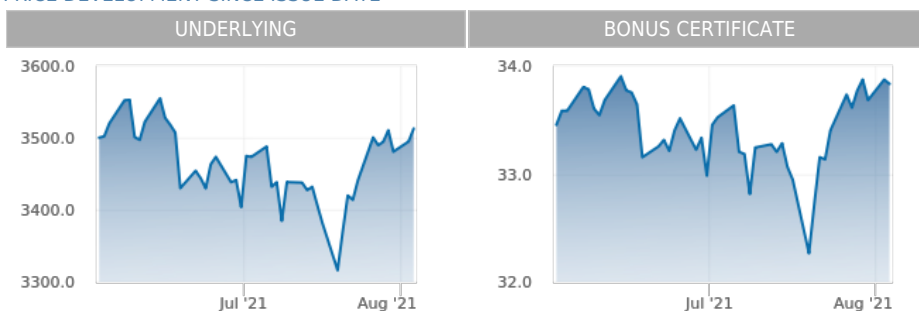

#### DESCRIPTION
