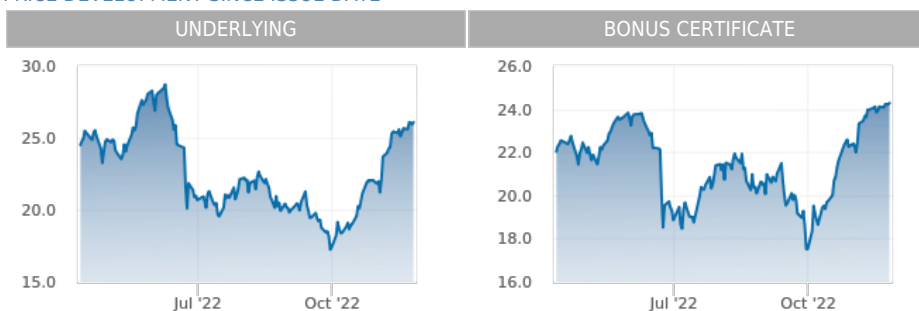

#### DESCRIPTION
