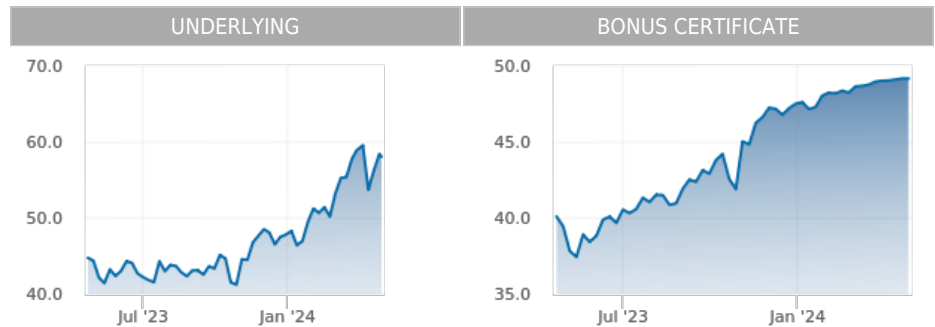

DESCRIPTION
