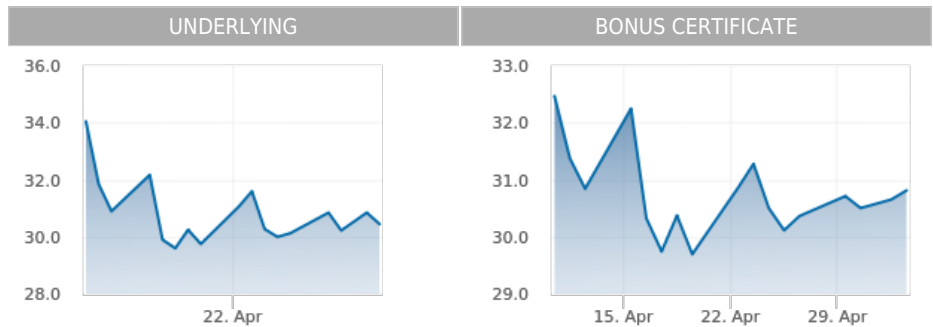

DESCRIPTION
