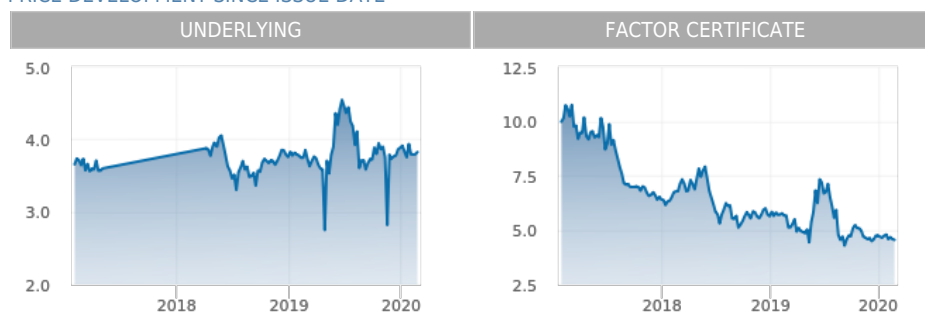
#### DESCRIPTION
