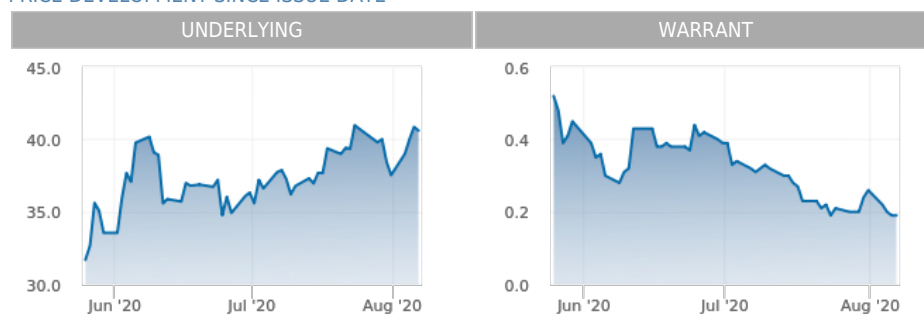
**DESCRIPTION**
