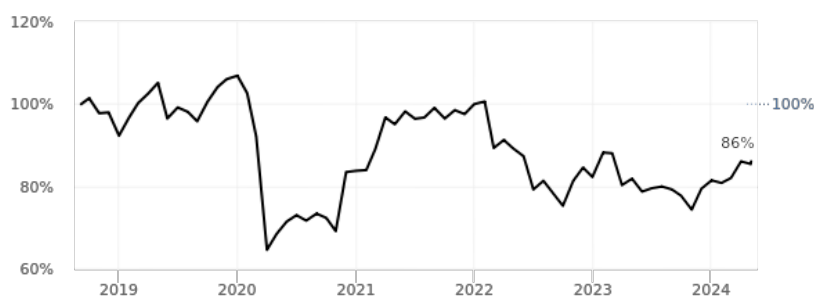

The Underlying

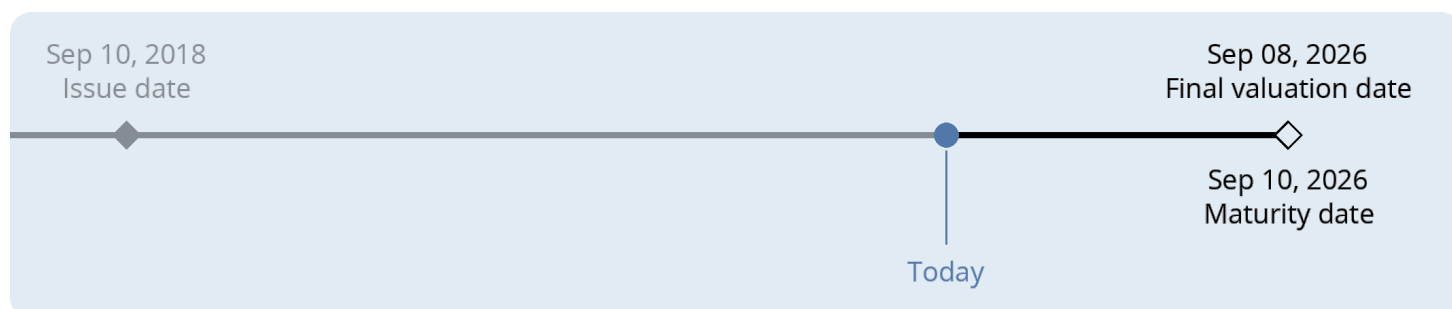
