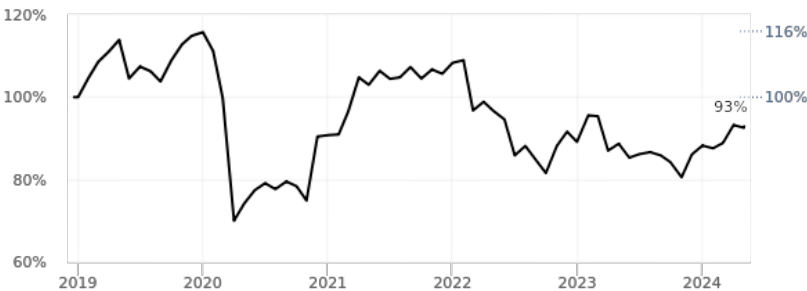

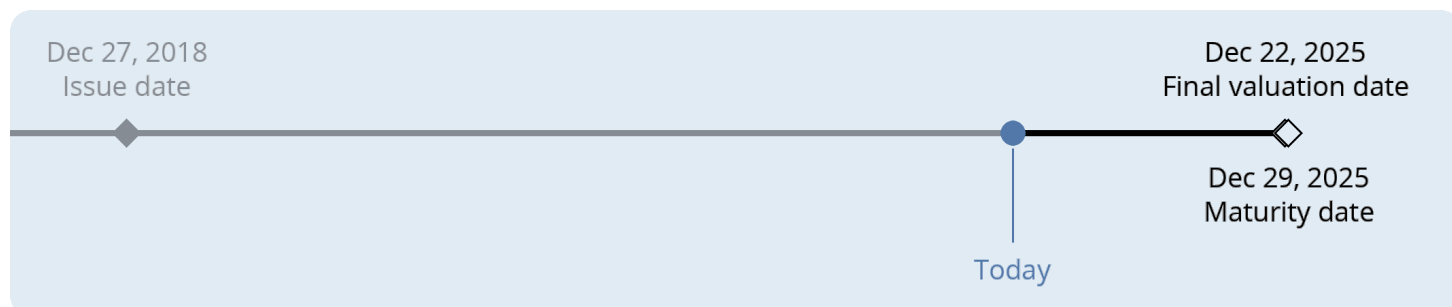
The EURO STOXX® Select Dividend 30 contains only equities from the eurozone, with the EURO STOXX® serving as the investment universe.
