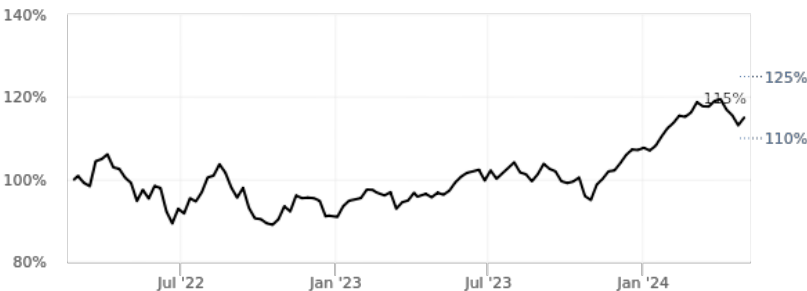

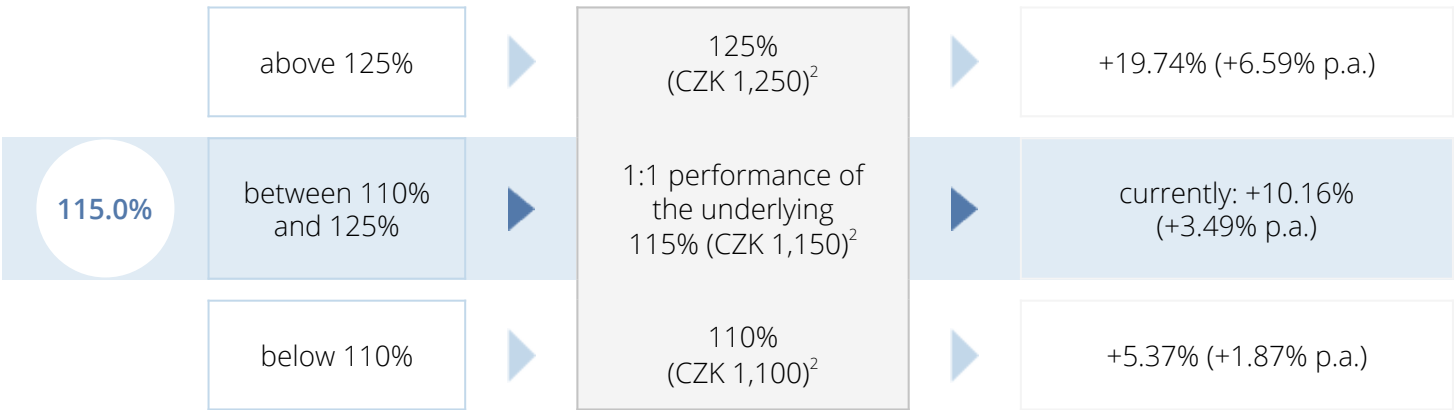

The Underlying

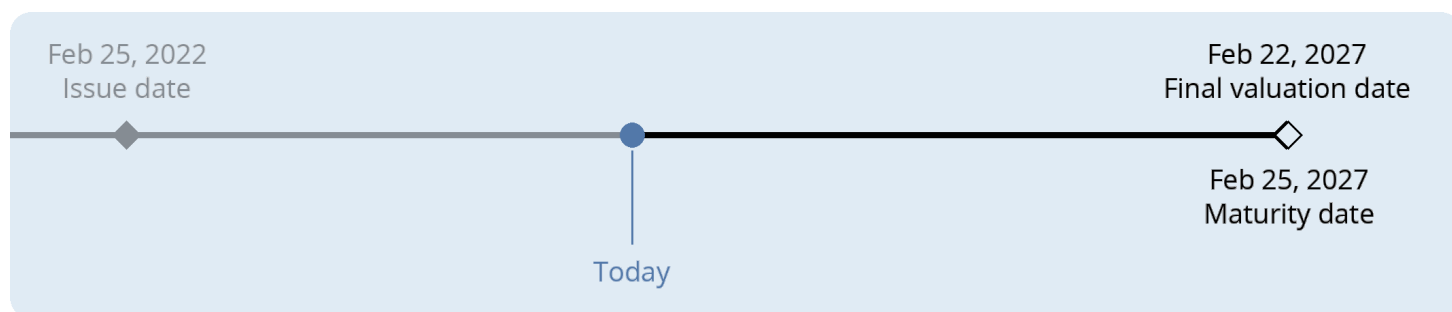

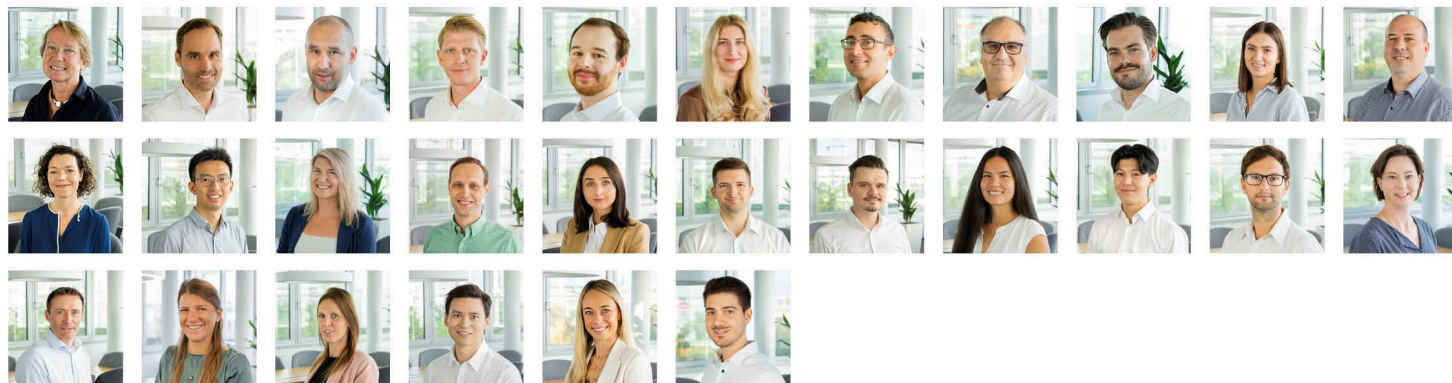
