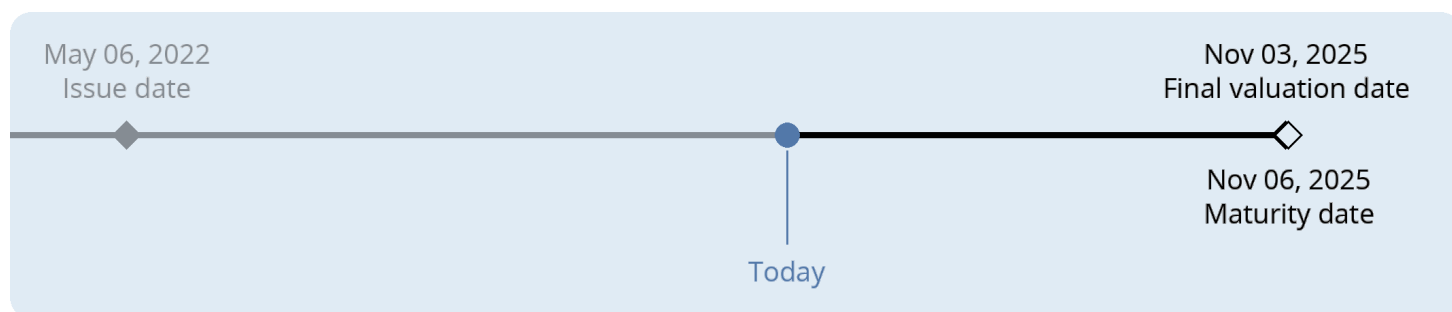
The Certificate
