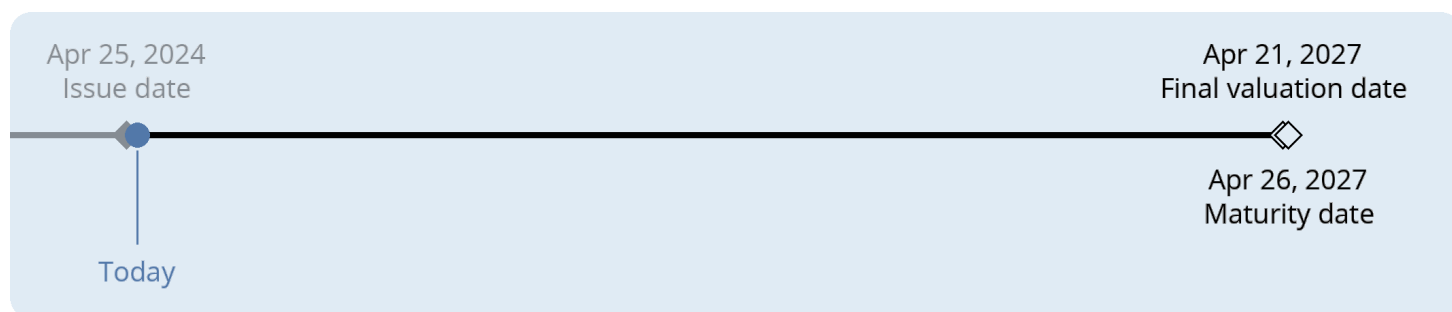
The Certificate
