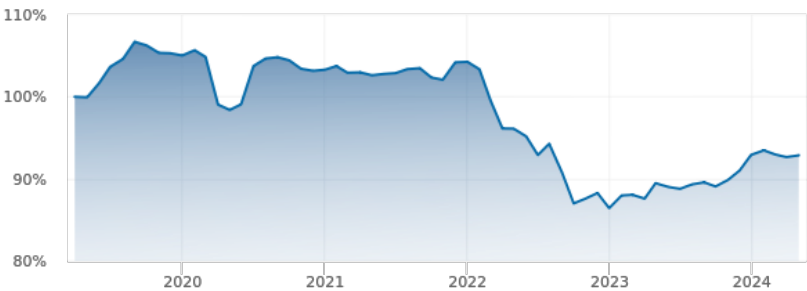

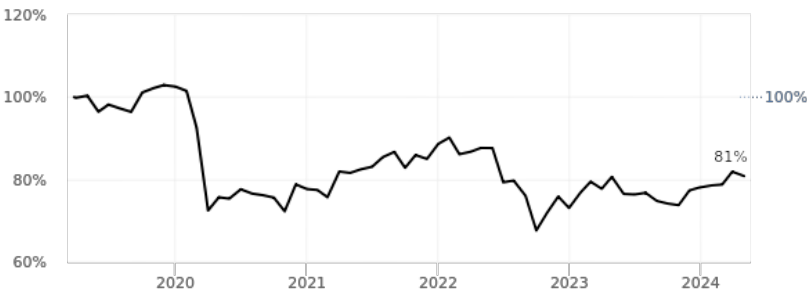

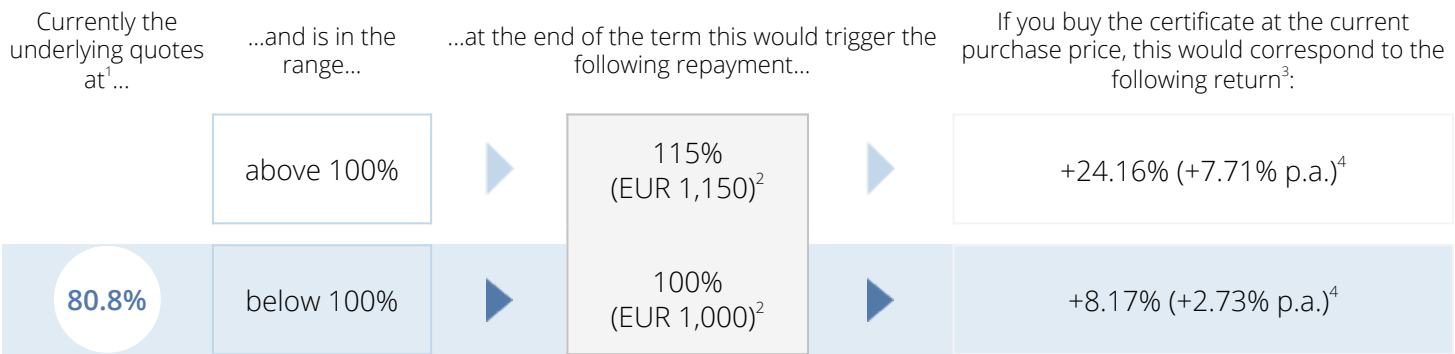


Price underlying (% of the starting value)

## The Underlying

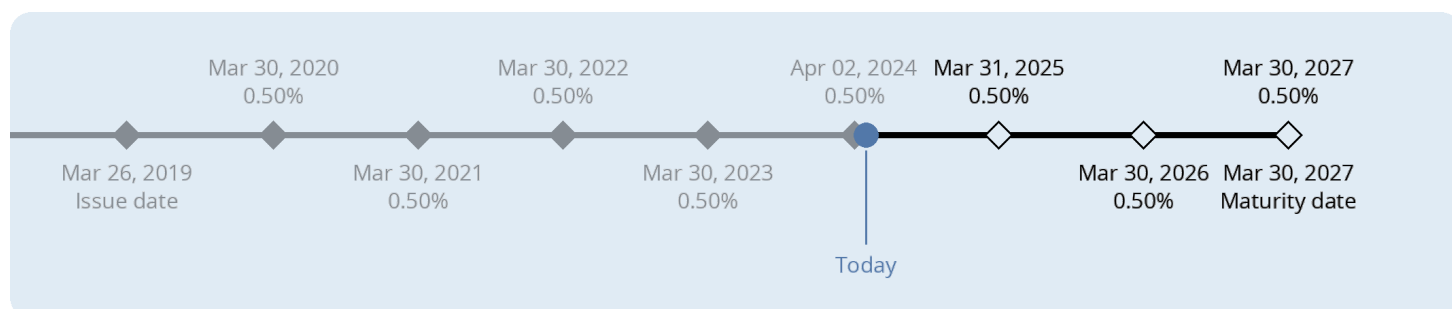
