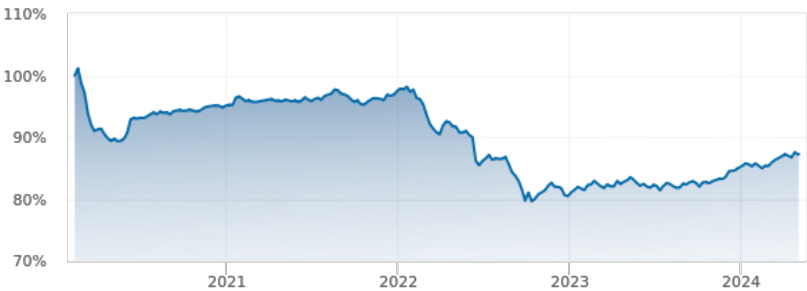

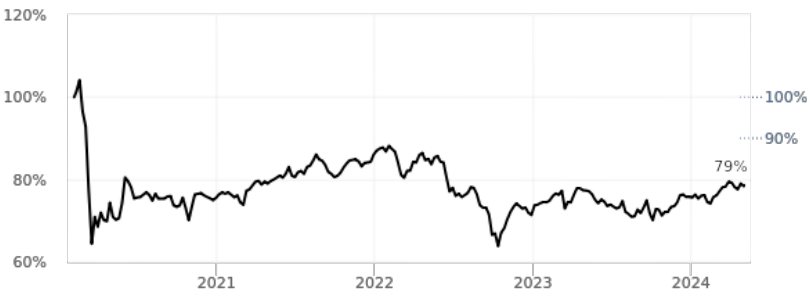

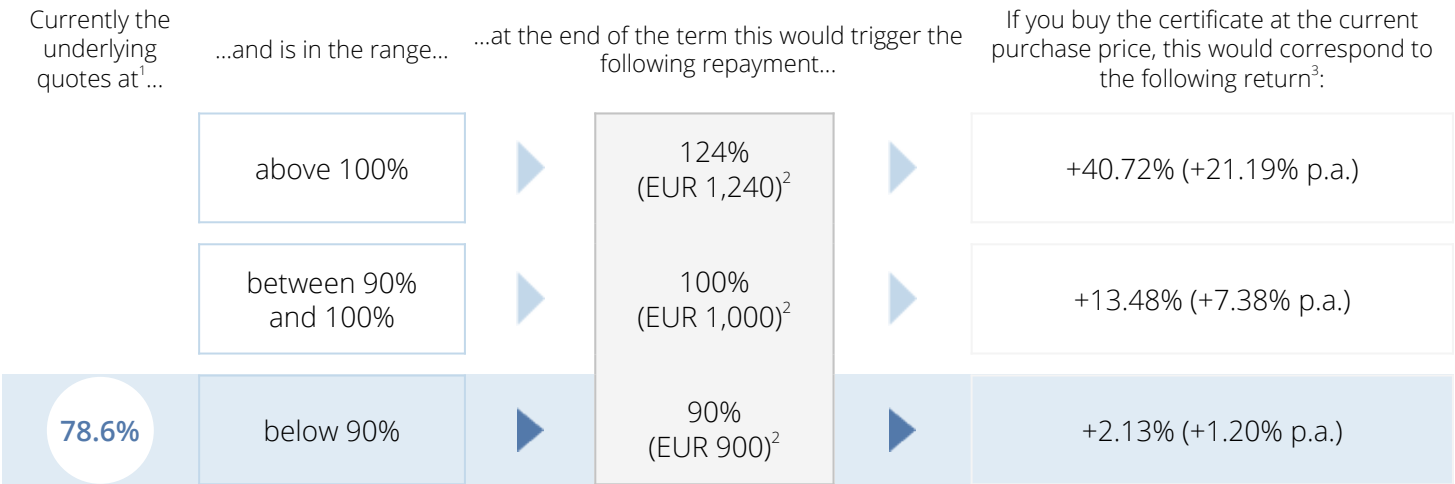


Price underlying (% of the starting value)

The Underlying

Ranking: Based on key figures from the sustainability experts at Sustainalytics.

Select: Stocks with low volatility and high dividend yields are selected.
