

INFORMATION ON DATA PROTECTION PURSUANT TO ARTICLE 13 AND 14 OF THE GENERAL DATA PROTECTION REGULATION (GDPR)

We process personal data that we receive from you as part of your job application (e.g. personal details, trainings, career). In addition, we process data that we legitimately receive from third parties (e.g. letter of reference), because you have given your consent.

You explicitly give consent to the processing of your personal data relating to your job application at Raiffeisen Centrobank AG ("RCB") via the Internet portal of sage GmbH ("Sage") pursuant to Article 6 (1) (a) GDPR and Article 7 GDPR. RCB and Sage process your personal data in accordance with the provisions of the Austrian Data Protection Act as amended from time to time, and the General Data Protection Regulation.

Your application as well as all information relating thereto are treated by RCB and Sage, as contractual processor, strictly confidentially and are processed solely for the purposes of the recruitment for which you have given us your consent. Within RCB, those units or employees receive your data, as required by them to process your application.

Your application and your personal data are processed by RCB for the duration of the recruitment process and for a period of twelve months after its completion. Once you submit a new application, this term starts running again.

You have the right to access, rectification, erasure or restriction of the processing of your stored data, a right to object to processing and a right to data portability in accordance with the requirements of data protection law. Withdrawal of consent:

Upon receipt of your withdrawal of consent, the processing of your personal data as part of your consent is no longer permitted. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

You are not obliged to provide your personal data. If you do not provide us with these data, we will be unable to carry out the recruitment process and would be forced to end such process.

In the course of the recruitment process, we do not use fully automated decision-making within the meaning of Article 22 GDPR. A profiling within the meaning of Article 4 (4) GDPR does not take place.
